

PUBLIC NOTICE

JERSEY CITY MUNICIPAL UTILITIES AUTHORITY

In accordance with N.J.S.A. 40A: 11-36 and duly adopted Resolution 6/16/9 of the Commissioners of the Jersey City Municipal Utilities Authority ("JCMUA"), sealed proposals will be received by JCMUA in the Anthony J. Fiola Conference Room, Administration Building, 555 Route 440, Jersey City, New Jersey on **September 22, 2016 at 2:00 p.m.** prevailing time, for the sale of personal property to the highest bidder. At that time and place, the sealed bids will be opened publicly, and read aloud for consideration by JCMUA.

The items listed below are being offered for public sale to the highest bidder at no less than the minimum price set forth in the bid packet. The sale shall be conducted by the Purchasing Agent of JCMUA or his designee.

The personal property items are being sold "as is" and "where is" without any representation or warranty, either expressed or implied, as to their present condition. Bid packages shall be available after the publication date. The majority of these vehicles are not running and are being sold as scrap metal.

JCMUA will first offer the entire list of vehicles as a "bulk bid" for sale at a minimum price. If the bulk bid is unsuccessful, then each of the vehicles will be sold on an individual basis at a price no less than the minimum price listed in the bid package.

At the time of sale, successful bidders must make payment in full or leave a 10% deposit. JCMUA will accept a non-refundable deposit for ten (10%) per cent of the total amount bid and accepted, with the balance to be paid within five (5) days of the receipt of proposals. The deposit may be remitted either by check or money order made payable to the Jersey City Municipal Utilities Authority, or by debit or credit cards. There is a 3.5% service charge. However, any balance must be paid by certified check or money order only. No items may be removed until payment in full is made.

All items must be removed from JCMUA's premises no later than ten (10) working days after the receipt of bids. After ten (10) days, JCMUA will hold the bidder in default and any and all monies paid by the bidder will be forfeited.

JCMUA reserves the right to accept or reject any or all bids it deems to be in its best interest. Awards shall be at the discretion of the Purchasing Agent or his/her designee.

No item will be sold unless the minimum bid is received. In the event of an item receiving the same Bid Price, the Purchasing Agent will conduct an auction and the property will be awarded to the highest bidder.

All items will be available for public inspection between the hours of 9:00 am to 3:00 p.m. at JCMUA's West Side Plant, 555 Route 440, Jersey City, NJ 07305. If it becomes necessary for the bidder and/or purchaser, either as principal or by agent or employee, to enter upon the property of JCMUA to inspect or remove property hereunder, the bidder and/or purchaser shall covenant and agree to take use, provide and make necessary and sufficient precautions, safeguards and protection against the occurrence of any accidents, injuries, damages or hurt to any person or property during the process of

the transaction and to be responsible for and to indemnify and save harmless JCMUA, its Commissioners, officers, agents or employees, and the City of Jersey City from all claims and damages by reason of any accidents, injuries, damages or hurt that may happen or occur and all fines or penalties assessed under any ordinance, regulation of law of the State of New Jersey or the United States while on JCMUA property.

All bidders are urged to physically inspect the equipment on inspection day or before submitting a bid.

Anyone tampering with or removing any part or accessory or making any adjustments as to remove the unit in an inoperative state will be removed from the bidders list and will be liable for prosecution.

Under no circumstances will a refund or adjustment be made because of equipment not coming up to the standard expected, nor will failure to inspect be considered grounds for a claim. **ALL SALES ARE FINAL.** JCMUA will not be responsible for any inaccuracies on any documentation.

All bidders should check all applicable paperwork as to accuracy before any purchase is made.

All bidders must be at least eighteen (18) years of age. Children will not be permitted at the sale or on the grounds.
