#### **DEFERRED RESOLUTIONS**

<u>Resolution 8/16/7</u> authorizing the declaration of an emergency on Pavonia Avenue between Corbin Place and Van Wagenen Avenue

Commissioner Vigil asked if pricing for the heating units was reviewed and found to be reasonable.

Mr. Haytas explained that funds have been allocated but the matter is not yet resolved with the property owner's insurance carrier. "Nothing's been done with the furnaces."

Mr. Carr further explained that a claim has been filed with JCMUA's insurance carrier. The carrier will offer replacement cost but not new units and negotiations are currently taking place. Per Mr. Carr, William J. Guarini Plumbing, Inc. will submit its bill and a copy of the invoice for furnaces. If this appears excessive, the MUA will take measures.

Commissioner Vigil asked if the matter will be resolved before cold weather and the need for heating.

Mr. Carr replied, "I believe it will be."

Mr. Haytas added that piping will remain the same and there will be no need for new piping.

<u>Resolution 8/16/9</u> authorizing the award of a contract for professional engineering services to CME Associates for the development of an asset management plan for the Jersey City Water System

Commissioner Vigil noted the contract called for an asset management plan. He suggested a matrix could be helpful and the contractor could assist with developing it.

Per Commissioner Gibbons, it would be a "good idea" to develop a matrix/asset management plan for the sewer side.

Mr. McClelland, CME Associates, offered to provide matrix suggestions/assistance.

Commissioner Macchi asked if the JCMUA's low interest loan required an asset management plan.

Mr. Folk explained an asset management plan is not required at this time but there are additional requirements/regulations by the DEP, and the DEP did ask the status of the Authority's asset management plan. He believes such a plan will be required in the future; "maybe next year."

Commissioner Macchi asked if "someone from Hudson County approves the loan," and Mr. Folk replied, "No."

# **EXECUTIVE DIRECTOR'S REPORT** – Mr. Becht reported on the following:

- 1. <u>Contract for laborers</u> Several offers have been made but no response has yet been received from the union. Awaiting response from the union.
- 2. <u>Kick off meeting</u> with General Counsel, Suez/United Water and Finance was held to discuss/review contract with Suez. The meeting was "very fruitful," and many suggestions were made. "We'll go back to the table after review. Much depends on water and sewer projects."

## **COMMITTEE REPORTS** – No reports

<u>COUNSEL REPORT</u> – Per Mr. Borin, "nothing at this time." He thanked the JCMUA and its Board of Commissioners for reappointment of the DeCotiiss, FitzPatrick et al firm as General Counsel.

<u>ITEMS OF UNFINISHED BUSINESS</u> - Unfinished Business Agenda/Action Item(s) for August 2016 Commissioners meeting:

<u>ITEMS OF NEW BUSINESS</u> – Commissioner Vigil discussed the transfer of the East Side plant property to Liberty Science Center/Liberty Humane Society, and asked if there is any possibility of encroachments. He explained that moving forward the City must abide by standards set by the State DOH and DEP.

Per Mr. Becht, Liberty Human Society is looking for a storefront site, and this is "not related to the MUA."

Mr. Borin added that he will "double check and let you know."

Mr. Haytas explained that per the survey, there is no encroachment.

Chairwoman Tauro then requested that temporary name plates used during Commissioners meetings be replaced with more permanent ones. She also requested that hard copy of each month's Commissioners meeting documents be mailed to her.

Per Mr. Becht, he will see to it that new name plates are ordered, and that Commissioner Tauro receives her meeting package by mail rather than electronically.

Commissioner Gibbons recalled last month's request from the Environmental Committee asking that someone address the status of the City's water supply.

Mr. Becht recommended Commissioner Gibbons reach out to Elmer Andal and stated, "We are more than happy to meet with them."

<u>WATER REPORT</u> – Mr. Hroncich advised that approximately five inches of rain fell in July. "We're doing well and in the 80 percent range which is good for this time of year." Hopefully there will be more rain.

Commissioner Macchi asked if all municipalities/towns "go dry" at the same time when a drought is declared.

Mr. Hroncich explained the State first issues a drought watch, then a warning and finally an emergency. When an emergency is declared, steps are taken to balance all reservoirs and share the water supply.

Commissioner Macchi then requested a copy of the contract concerning recent testing of the City's water supply and briefly discussed the potential for criminal charges in the Flint, Michigan drinking water matter.

Mr. Becht assured Commissioner Macchi that a copy of the contract for water testing will be hand delivered to him. He added that the contract provides indemnification and insurance and that everything was done correctly and legally.
